ANNUAL REPORT AND FINANCIAL STATEMENTS

The Audited Financial Statements for the year ending 30 June 2022 were presented to the Council by the External Auditor at the November Council Meeting.

The Auditor outlined that Council's overall operating result from continuing operations for 2021/22 was a deficit of \$5.97 million.

The net operating result when excluding capital grants and contributions was a deficit of \$19.72 million, largely due to depreciation expense as a result of a revaluation of water and sewer assets required every five years.

The financial statements are included in council's 2021/22 Annual Report which is the yearly report to the community documenting activities and finances over the previous year.

The Annual Report describes how the organisation has met its annual objectives and priorities.

During the year, the low supply of materials and workers as a result of COVID-19 interfered with how we delivered work and some services.

Despite these obstacles council was able to deliver 103 (87%) actions and initiatives identified in the 2021/22 Operational Plan and rolled over a further 12 (10%) initiatives to be delivered this financial year.

We delivered a \$63.8 million Capital Works Program, collected 1,596 tonnes of recyclable waste, awarded \$116,236 in community grant funding, determined 193 Development Applications, delivered 190 Library programs, registered 287 pets, and engaged with 162,003 viewers via social media, just to name a few.

Speaking of young people setting a great example, I must also commend the pupils of the local Tumbarumba and Rosewood schools for the way they helped organise and officiate at the Remembrance Day ceremony on Thursday at the Tumbarumba Cenotaph. Along with the members of the RSL Sub-Branch a very fitting commemoration was observed and it certainly spoke to me that we have some very capable young people within our ranks to be the future leaders.

On Friday 4 November I attended an afternoon tea to acknowledge a number of staff from the Tumbarumba Hospital who have retired in recent times. In some cases, over 40 years of service to the community. Well done and thank you.

I would like draw to the attention of rural landowners the recent release of the Native Vegetation Regulatory Map. The Snowy Valleys Local Government Area is one of 11 council areas that the Department of Planning and Environment has released the draft mapping for. Given that there has been issues with vegetation clearing in recent times I would commend land owners to familiarise themselves with this mapping tool as it will indicate the various categories of land that are subject to regulations on clearing.
