Draft Cemeteries Policy

## What is your feedback?

Responding to SVC Draft Cemeteries Policy. Section 4.1 (General Provision): "Council is responsible for the....maintenance of cemetery grounds of all public cemeteries in the LGA..." As a member of , I wish to draw attention to the high conservation value of sections of the grounds of both Tumbarumba Cemetery, and Rosewood Cemetery. Rosewood Cemetery contains a representation of the original flora pre-European settlement. The grounds have not been subject to pasture improvement and annually bring forth a vast amount of Golden Moth Orchids, Billy Button daisies (Craspedia variabilis), Bullseye lilies (Wurmbea dioica) in September-October each year, particularly on the mown sections. The same is true of parts of the Tumbarumba Cemetery, particularly the open area between the Roman Catholic section and Anglican section. This area still has Kangaroo Grass and Windmill Grass as its dominant (native) grass layer, although (non-native) Paspalum has begun invading this area in recent years, its seeds being carried on the Council ride-on motor mowers. Rosewood cemetery is a valuable example of Tablelands Snow Gum ecological Community. In addition to those listed above, it contains many native plants which are now locally rare, including Gompholobium huegelii (Pale Wedge Pea), Ajuga australis (Austral Bugle), several different types of native lilies, daisies, peas, herbs, forbs and orchids. These ground-layer native vegetation have been much impacted elsewhere in the Shire by continuing road-widening and clearing operations (e.g. Coppabella Road Upgrade 2018-19), the continued and ongoing fragmentation of Native habitat within the Snowy valleys Council LGA, the domination of

Therefore, I am requesting that Council would consider consulting with concerned locals and our nominated representative (e.g. **Constitution of the second secon**

After nearly two weeks of enquiry, I am requesting and extension for public comment of the cemeteries policy SVC-COR-PO-014.

To date I have been unable to obtain the relevant information from council to make comment. I have requested a copy of the current cemetery policy as to make comment relevant to any changes. The SVC web-site does not have this currently available, for the past two weeks at least.

I do wish to make comment on the following aspects of the cemeteries policy.

- 1. (4.4) Grave reservations. The costs involved with reserving a plot, is this then credited against the costs of interment when made? If not what is the reservation fee actually paying for?
- 2. (4.7) Monuments. The section saying "Council shall not be held liable for any damage to headstones or monuments caused by normal wear and tear, ground maintenance or other parties". We strongly disagree with this statement. Families spend a lot of time and at times money to have memorials designed, manufactured and installed. If an individual, business or council has caused damage to such works, they should be responsible for the repair. This leads to an issue that SVC has with the current version of the memorial application.
- 3. Memorial works being carried out within SVC cemeteries. "Application for permission to carry our monument". Does this form a part of the SVC cemetery policy?
  - Councils point (4.7) damages to monuments statement. The current application for permission to carry our monumental, asks: As the contracted Mason I confirm that I have:
    (1) Public Liability Insurance (2) System of safe Works (3) Workers compensation (4) Liability Insurance for all vehicles (5) white card for all workers. This is currently a tick and flick exercise, no proof requested. From this as stated above, if damage does occur, there would be insurance to cover it.

As I believe, from memory only, that what is currently on display for comment is not the full SVC cemeteries policy. There a sections missing. I cannot make full representation for comment on the draft policy until viewing the current.
