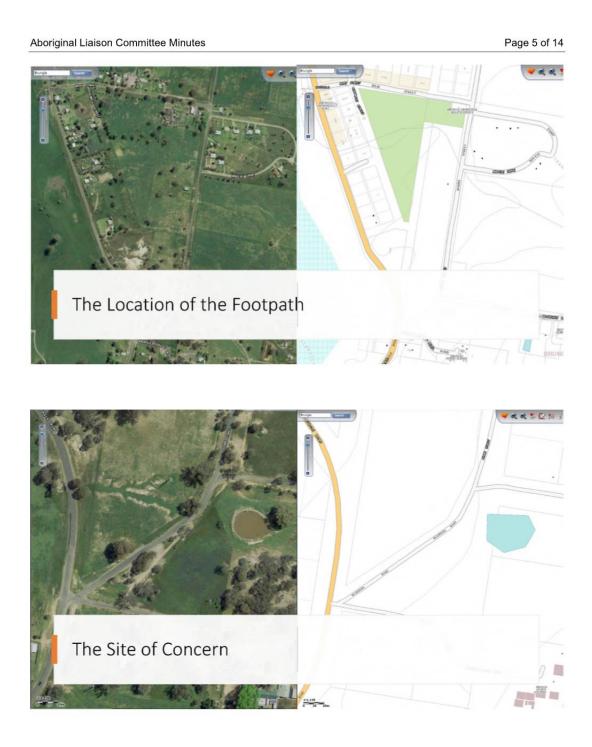

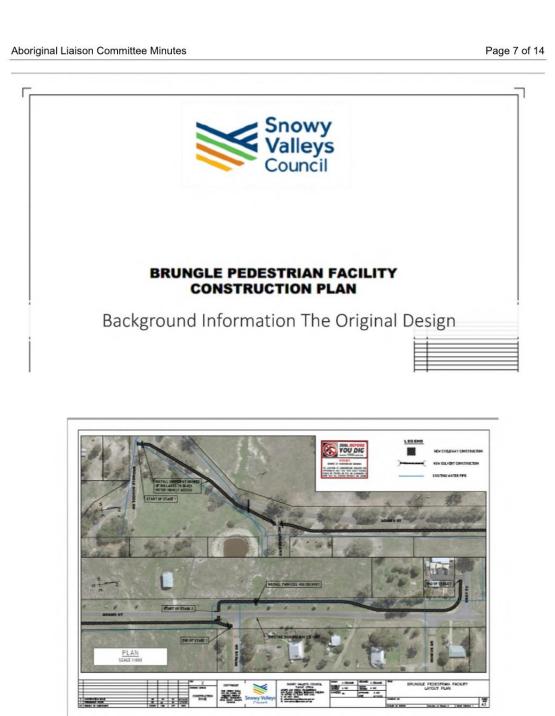

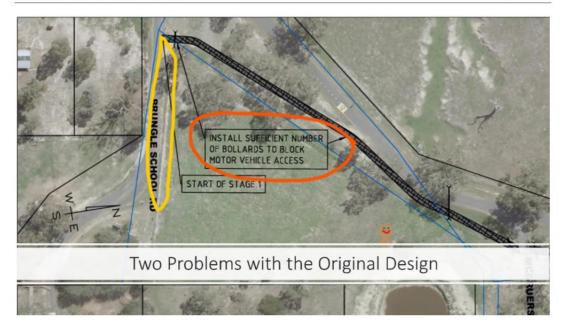

4. East Gilmore Road and Batlow Road (MR4) Intersection

This intersection is a crash hotspot.

The design and treatment of the intersection aim was to slow road traffic speed.

A Road Corridor Investigation of Batlow Road MR85 is under way.

ACTION: A community information session or a press release is to be organised from TfNSW.

5. Plan Your Trip Signs for Snowy Mountains Highway

The process to install 'Travel Time" signs along the Alpine Way is underway.

This signage would inform visiting motorists and motorcyclists of the distances involved and would assist in reducing fatigue.

RECOMMENDATION:

That Council request TfNSW to plan and install similar "Plan Your Trip" signage along the Snowy Mountains Highway and Gocup Road as the signs planned for the Alpine Way.

6. Location Markers on Snowy Mountains Highway up Talbingo Mountain.

Snowy Hydro and contractors have requested that location markers be installed on Talbingo Mountain on the Snowy Mountains Highway (MR4).

TfNSW is undertaking a Route Safety Investigation upon MR4 Snowy Mountains Highway. Concerns with location markers were noted.

7. Cameras Along Snowy Mountains Highway for weather conditions.

TfNSW is undertaking a Route Safety Investigation upon MR4 Snowy Mountains Highway. Snowy Hydro have installed Gantry Signs outside of Tumut to inform road users of road conditions.

Suggestions include installing footpaths and rerouting driveways.

Grant funding would need to be sought.

10. Travers Street Adelong

Converting Travers Street from a through way to a closed cul-de-sac has been discussed by Traffic Committee.

A similar design could be made to closing Lynch Street to through traffic.

RECOMMENDATION:

That Council make a design and estimates be made to block the north end of Travers Street to through traffic using chevrons so that Travers Street can become a cul de sac, these plans would be presented at the next Local Traffic Committee meeting.

11. Glen Estate Tumut traffic

ACTION: Traffic data be collected and presented as a report to the next traffic committee.

This information would be used to discuss what traffic measures that could be appropriately implemented.

12. Speeds Zone Adjustments

Speeds zones are the responsibility solely of TfNSW.
