The Aboriginal Cultural Protocols and Practices Policy has been out for consultation with the Aboriginal Community since May 2018. The Policy was finalised at today's meeting and is ready for adoption by Council.

Snowy Valleys Council Acknowledgement of Country

The wording for the Acknowledgement of Country is included in both the MoU and the Aboriginal Cultural Protocols and Practices Policy. Both of these were finalised at today's meeting and are ready for adoption by Council. The wording for Acknowledgement of Country is:

"I would like to acknowledge the traditional custodians of this land and pay respects to Elders past and present".

GENERAL BUSINESS:

 There are two trees out the front of Cooee Cottage that are lifting up the roadway and are causing a trip hazard.

- Countrylink bus service will be established from Wagga to Canberra stopping at Gundagai. Is there are possibility of having Goodes connect with it at Gundagai. Would be good if it linked through Brungle.
- Concern raised about a potential dam at Mingay (near Coolac). The other option is for a pipe to be run. Geoff Pritchard to keep Aboriginal Liaison Committee informed.
- Is there a possibility of a school bus stop being put in place on the corner of Adam and Bray Street? This would be beneficial for children who catch the bus into Tumut.
- Could a pedestrian crossing be installed in the main street of Tumbarumba? Also can the stoppers in front of where the cars park be removed as they are a trip hazard?
- Question raised as to whether there will be any cadetships or apprenticeships offered for young Aboriginal people in the Tumut or Tumbarumba area?
- The flags in Brungle are torn and can these be replaced. Trudy Crawford advised that new flags have already been purchased and are with the contractor to be put up.
- Can Council check on a regular basis whether Brungle cemetery needs mowing?
 Also paths and seating need to be installed at the cemetery.
- Kayne Webber has spoken to Cooee Cottage regarding delivery of timber for wooden seating. When will the timber be delivered?
- Sue Bulger advised that Council has asked where the seat should be located in Brungle on the road or in the park? Sue was unsure whether this was the seat that was allocated for the playground or an additional seat. If it is an additional seat all felt it should be located at the Health Centre.
- When will the seating be installed at the Playground?
- Plantings at the hospital at Tumbarumba and in other public places should be natives.
- Rhonda Casey advised that she has been liaising with Snowy Hydro regarding 2.0
 who are keen to start running forums for training of young people in schools. They
 will be looking for indigenous employment down the line.
