4.4 Floodplain Risk Management Process

Steve Manwaring, Senior Natural Resource Officer (Floodplain Management) provided an overview of 2023 Flood Risk Management Manual and Flood Prone Land Policy, Floodplain Management Program, Flood Risk Management Framework, Flood Risk Management Committee, roles and responsibilities in a presentation to the Committee (Attachment 1)

- The role of the committee is to assist council in developing and implementing a FRM plan by contributing ideas, professional expertise, experience and local knowledge.
- · Form a link between the Committee and the wider community.
- To operate as a team with the community's interest being foremost.
- To actively direct the course of FRM studies to ensure they represent the views of the Committee, not only those of the consultant and Council.
- Committee members may be required to vote to determine the majority opinion on different issues.
 However Federal, State and Local government representatives should not have voting rights as their role is to provide technical advice and guidance to the Committee based on their respective areas of expertise.

4.5 Tumbarumba Flood Study - Scope of Works

WMA Representatives, Erin Askew and Kajah Melhan presented to the meeting to provide an overview of WMA and the technical work to be carried out.

WMA discussed how they will proceed in preparing a flood study, defining the existing flood behaviour for the Tumbarumba catchment and produce flood velocity and flows, the identification of flood risks in Tumbarumba, data collection, the development of hydrologic and hydraulic models, flood events and model outputs.

Understanding the flood risks in the area, community engagement, identifying development/urbanisation pressures. The utilisation of tools to assist in the management of flood risk - development controls.

There will be multiple opportunities for the community to be involved via consultation for the duration of the floodplain management process ie; media releases, questionnaires, information sessions, public exhibitions and Floodplain Risk Management Committee Meetings. There are also established community groups ie; resident associations, landcare groups, Chamber of Commerce that will be consulted with the Committee to determine the consultation process - questionnaire, group discussions or drop in sessions.

The study will be carried out in accordance with best practice industry standards ie; Flood Risk Management Manual and the Australian Disaster Resilience Handbook.

Once the study has been completed then these results are presented to Council prior to proceeding with design flood modelling.

WMA would be interested in photographic evidence of past flooding events. If the Committee members or other community members have any could you please forward them to Mark Kirton, Co-ordinator Growth and Development in the first instance.

For any Snowy Valleys Council social media content please also direct to Mark to forward to the Media and Communications Team.

WMA will have further consultation material for the community within the next month.

4.6 Nomination of Dates for 2023/2024 Meetings



FRM Manual & Flood Prone Land Policy

- The new Flood Risk Management (FRM) Manual 2023 has been gazetted as the 'Manual' relating to the management of flood liable land - as stated under s733 of the Local Government Act 1993
- The management of flood prone land in urban areas within NSW is generally the responsibility of local Councils.
- s733 of the Local Government Act 1993 provides indemnity if Councils act in good faith and in accordance with the FRM Manual
- The Manual and its Toolkit support Councils to understand and manage flood risk to their communities
- Adhering to the Manual provides Council with an opportunity to access funding via the NSW Floodplain Management Program

Floodplains are strategically managed for the sustainable long-term benefit of the community and the environment, and to improve community resilience to floods.


Principles for flood risk management in New South Wales

- 7. Consider variability and uncertainty
- 8. Maintain natural flood functions
- 9. Manage flood risk effectively
- 10. Continually improve the management of flood risk
