Participants learn common ratios used by boards to monitor performance and consider issues to be mindful of when questioning management on the preparation of financial statements and when reviewing financial reports.

Strategy and Risk: Issues for Councillors.

An introduction to the Councillor's role in relation to strategy and risk is designed to provide Councillors with the basic tools needed to take a confident and active role in their strategic and risk governance roles.
