## 8.4. REQUEST - TUMUT TOWN BAND - CHRISTMAS MORNING PLAY OUT

A non-pecuniary interest had previously declared by Dossie Carr in relation to this Item.

Discussion & assessment of this application had been held in relation to this Item and it was determined that it would be breaching current road rules and therefore the Local Traffic Committee would not support this Special Event Application. It would not be as part of a closed road environment or part of a special event traffic management plan and it would not be compliant with the road rules as such, with just a Band sitting on the back of a truck and moving in normal traffic. It was raised by Dossie that this was a tradition that had been ongoing since 1925. Further advice was provided by TfNSW that there would be no special approval provided for this Event as TfNSW is included as an interested party on any public liability insurance and as it falls outside the Guidelines for Special Events, TfNSW would not support such an application.

## 9. GENERAL BUSINESS:

- Clr James Hayes advised the Committee that Council had received some funding for the
  planning for the upgrade of the main street in Adelong. Clr Hayes advised that he had been
  approached by a resident of Adelong who wanted it made known that they experience on a
  regular basis, people parking across their driveway.
- Brungle speed limits it is believed that Transport for NSW had undertaken an assessment. Glen
  to follow up with Greg Minehan as to what stage this assessment is up too.
- Jackson's Bridge, Tumbarumba, realignment funding applications for "Black Spot" funding had been submitted on at least two (2) prior occasions. Chris Blake to follow up further with Justin Clancy.
- The next "Coffee with a Cop" has been scheduled for 13 December, 2023, to be held in Tumut. Discussion had also been held at a previous Local Traffic Committee meeting, that a traffic counter be placed at the entrance to "The Glen Estate". Data will be provided to the next Meeting.
- A request had been previously made to Transport for NSW for signage for Motorcyclists prior to the entrance of the "Snowy Mountains Highway". To date nothing has been done in relation to this.
- Council has received a request from the Transmoto Event for a letter of support from the Local Traffic Committee. A support letter had previously been given by Council, however, nothing had ever been tabled at the Local Traffic Committee.
- Road signage on Brindabella Road i.e. "Road Unsuitable for Caravan's etc..." question asked as to whether or not this was a Local Government responsibility or would it come under Transport for NSW. Committee advised that there is a "caution road surface conditions vary, this road is unsuitable for caravans and trailers". Sign is a prescribed traffic control device and it is not delegated to Council to install. Can only be installed by direct Transport for NSW written approval. Reference # for sign is G9368-1. Manager Technical Services to follow up and provide letter to Transport for NSW.
