Subject: Request to close Snowy Valleys Council reserve road on Lot 4 of Deposited Plan (DP) 865358 IAW section 38A of Roads Act 1993

Accept this letter as an official request to Snowy Valleys Council (SVC) to close a SVC reserve road and right-of-footway easement that transects Lot 4 of DP 865358 located in the Goobarragandra valley. This request is made under §38A of the Roads Act (1993). This area is approximately 5,700m².

Another request to close a nearby segment of the same SVC reserve road was promulgated recently in local media (*Tumut and Adelong Times*; 24/09/21). We respectfully request that both road closure proposals be assess concurrently. Logically and legally, both proposals should have parallel outcomes. Assessing both road closure proposals concurrently would prevent duplication, thereby reducing effort and producing a harmonious outcome.

As with the aforementioned proposal, should closure of the reserve road detailed in this letter be approved, we expect SVC to sell us the land from the road closure as adjoining landholders.
