- Council has been approached by resident with concerns on various items of Council's infrastructure i.e. foothpaths and driver behaviour towards cyclists. The Road Safety Officer is to check Council's Road Safety Action Plan with a view to updating, if required.
- The Committee was advised that the date for the "Bloom" Special Event has been changed to the 26 October 2024, due to original date coinciding with the Visy major shutdown and the lack of available accommodation in the Tumut area.
- Council's Event & Grants Officer advised that she is currently working on updating Council's Special Event Application form, with a view to having a Draft version to present to the next Local Traffic Committee Meeting for discussion.
- Brungle Committee have expressed their gratitude for the installation of signs in their Area.
- Road Safety Officer advised that new road signs for wildlife i.e. deer, kangaroo, etc had been installed on the Tooma Road i.e. in the Tooma/ Khancoban area.
- TfNSW advised that a speed zone assessment is currently being undertaken on MR85 in the Batlow area with a view to extending the 80km/hr speed zone along the main Orchard areas to the rest area (Cow & Calf) to the north of Batlow.
- Vehicle traffic in Fitzroy Street, Tumut, in the vicinity of the Swimming Pool (intersection Fitzroy
 and Richmond Street). Raised in regards to safety at intersection and potential impacts at the
 adjacent pool. Questions as to whether or not bollards could be installed as a safety feature.
- Complaint had been received in regards to vehicle access on to the Snowy Mountains Highway (near Jounama Dam entrance). Advised that a speedzone assessment is currently being undertaken of this area.
- Councillor Hayes spoke to the Committee and thanked the Committee for their work during his Term as a Councillor representative on this Committee.
