9. GENERAL BUSINESS:

- TransportNSW a Development Application has been submitted to Council for a motorcycle
 event coming off MR85. Has been referred to TransportNSW for comment. Advised the
 Committee that they would have no objection to the Event going ahead.
- TransportNSW has been approached by the Timber Industry and Visy to investigate running an A-double (2 full trailers with a dolly - 30m) trial on most of the Networks. Still in the initial stages.
 Depending on the configuration would be approximately just under 92 ton.
- NSW Police currently working on a couple of upcoming Events in the LGA. Advised the Committee of proposed "Shovall?? Lighthorse Ride". TransportNSW has had had discussions with the Organisers and they have advised that it is not an Event. Accordingly the Organisers have made direct contact with various LCA's. However, the Organisers have now been advised by TransportNSW that it is an Event and that they need to submit a Special Event application and supporting documentation. To date the Organisers have further advised of what arrangements they are now proposing and thus aren't required to submit an application.

- Council has been advised of a 5 day cycle challenge (25-29 March 2025) "Challenge Snowys" Is
 a fundraiser for Cancer research. All required documentation has been provided to Council. Kylie
 Franco to distribute Event Application and supporting documentation to Committee members via
 email for information/ comment.
- Cr Thomson has raised the electronic message board located out near Blowering Dam.
 Apparently always displays "Live Traffic" Has asked the question if could have the "variable" message, like those that are located on the Hume Highway? If there was to be a change made to the messaging on the sign a request from Council would need to go to TransportNSW. Could also go through the Local Member's Office.
- Has provided Manager Technical Services with a couple of requests for speedzones. These will
 be uploaded through the Portal "Tumut Plains Road to Little River Road". Has also requested
 support from the Local Traffic Committee to advocate for passing lanes on the road between
 Tumut and Batlow and Batlow and Tumbarumba, essentially on MR85? TransportNSW will take
 that on note.
