Thank you for speaking with me today. In relation to your below queries:

Snowy Valleys Council (SVC) can continue to lease properties they manage, subject to a disclaimer that there is an Aboriginal Land Claim (ALC) lodged on the leased land.

As discussed during our call, SVC can continue to move forward with the request of the transfer of land Local Land Services (LLS) manages to SVC for continued management.

We suggest that should the transfer of management occur, that SVC may wish to request from LLS any records/evidence they may hold in relation to the lawful use and occupation, permits and essential public purpose relevant to the land an aboriginal land claim has been lodged over.

As you are aware the evidence required for the assessment must be relevant to the date the claim was lodged. As we currently have many ALCs on hand, it may be several years before these claims are actively assessed. Gathering and forwarding this evidence as soon as possible may assist with not having to go back to LLS to gather historical data.
